Architectural Review Board (ARB)

Please remember that any changes or alterations to the exterior of any structures or landscaping require residents to complete and submit an *Architectural Review Board Application Form* to Vista Management. The form is located on the website under the ARB tab at www.arrowheadstates.info


After you submit the completed form to Vista, our Architectural Review Board has 30 days to review and respond to your request. Work cannot start just because a form has been submitted; please wait for approval. Thanks for following our legal process! Community Pool Issues



Don't forget, children under the age of 16 are not to be in the pool area without a supervising adult.

If a **pool key** is needed, please contact Jo Ann Hughes or John Bagwell at Vista. Keys are given only to HOMEOWNERS who have no violations and whose fees are all current. If a key is lost and another key is required, the current fee for the 1st time replacement is \$15.00; 2nd time will cost \$25.00; 3rd time replacement fee is \$50.00.

 The **pool area closes at dusk**. Anyone on the premises after dark is trespassing (as the signs say) and can be arrested. Our security cameras monitor activity, and the police have apprehended teens illegally in the pool area. Please make sure everyone in your home is aware of this rule.



No glass bottles or grilling inside the fenced pool area. Let's keep our pool area safe!

How do I deal with a Notice of Violation?

Do NOT ignore the letters. Please also be aware that individual board members do not make decisions or have authority on architectural issues, so calling a board member will not help. If your fix is something that cannot be done immediately, **call John Bagwell** at Vista and let him know how you

plan to correct the situation and what timeframe you expect it to be completed.

Street Parking Safety Hazard



We are still having problems with cars parking on both sides of the street. This makes it difficult for normal traffic, but especially for **emergency vehicles** which are much larger and cannot pass between the cars. We ask that you be considerate of your neighbors and keep in mind the safety of everyone. Please ask your guests to park in your driveway or at least on the same side of the street so that traffic flow is not restricted. **Please avoid parking on the street altogether** whenever possible. Your neighbors will be grateful and those considering buying in our neighborhood will not be put off by parking issues. We want to attract good neighbors!
